Minutes

I. Welcome and Introductions (Don)

In person were board members Don and Deanne, presenters Trell, Ray, Fred, and Lory, and 21 neighbors. Via Zoom were 7 neighbors + our vice chair Ben

II. Trell Anderson from Northwest Housing Alternatives to give update on the fate of Rosemont Court (597 N Dekum St), an apartment complex for low-income seniors

Trell gave a very comprehensive history of the Legionnaires outbreak at Rosemont including the measures they went to trying to combat it. Funding that they had lined up for upgrades was lost due to the outbreak. What is needed now is 6 million dollars to replace the entire water system and make other needed upgrades that would take up to one year to complete, at which point all 99 units would again be available. It was clear that nobody wants to sell Rosemont, but without the necessary funding they may have no their choice. They have an application for funds pending with the Portland Housing Bureau. Their pleas to the City, County, and State for help have fallen on deaf ears. A neighbor suggested folks show up to advocate for funding at the weekly commissioner meetings. A neighbor asked about security and the porta potty on site. It was explained that there have been 2 waterline breaks so there are workmen working on fixing those. Additionally, a manager is on site 8 hours a week, there is a full-time maintenance worker, and security makes rounds 3 times a night. There was great concern for those who have been displaced, but the situation has no clear way forward at this point in time.

III. Fred Neal and Lory Hefe, Transition Engagement Coordinators from the City of Portland to discuss the City's transition in 2025 to: ranked-choice voting, a 12-member city council elected by district and a citywide-elected mayor to oversee a city administrator.

Fred gave an informative power point presentation on all things transition related. For those wanting more detailed information the website Portland.gov/transition is a wonderful resource.
